Justice Vinodh Coomaraswamy
The Supreme Court of Singapore

Justice Vinodh Coomaraswamy was appointed Judicial Commissioner in 2012 and a High Court Judge in 2013.

He graduated with a Bachelor of Laws from Nottingham University in 1990 and a Bachelor of Civil Law from Oxford University in 1998. He practised at the commercial bar from 1992 to 2012, all at the firm of Shook Lin & Bok.

He was appointed Senior Counsel in 2005. He is a Fellow of the Chartered Institute of Arbitrators and of the Singapore Institute of Arbitrators. He is also admitted to practise in England (1991), New South Wales (2005) and New York (2007).

The Honourable Sir Vivian Ramsey QC

Sir Vivian Ramsey qualified as a civil engineer before joining the English Bar in 1981, becoming a QC in 1992. He was head of Keating Chambers before being appointed a High Court judge in 2005 where he was judge in charge of the Technology and Construction Court from 2007 to 2010.

He was also heavily involved in the implementation of the Jackson Reforms which included a review of the costs of expert evidence.

Following his retirement in 2014 he was appointed as an International Judge in the Singapore International Commercial Court and acts as an arbitrator, mediator, expert and dispute board member around the world. He is a Visiting Professor at King's College, London and edits Keating on Construction Contracts, now in its tenth edition. He has had a long-standing involvement with EWI.

About the Chairpersons / Moderators



Prof. Leslie Chew SC - Dean, School of Law at the Singapore University of Social Sciences; Senior Consultant, RHTLaw Asia

Leslie Chew graduated from the law school of the University of Singapore (the predecessor of the present National University of Singapore), and was admitted as an Advocate & Solicitor of the Supreme Court of Singapore in 1981. He is also admitted as a Solicitor of England & Wales. He has been a lawyer for 42 years, practicing at the Bar for 32 years and 10 years in public service He was appointed Senior Counsel in 2000. Leslie is the founding and current Dean of the School of Law at the Singapore University of Social Sciences. As a lawyer he practices primarily at the Commercial Bar. From time to time he has represented clients in commercial crime or white collar cases.

In 2007 he was appointed a District Judge. He subsequently held office as a Senior District Judge heading the Civil Justice Division of the State Courts (then the Subordinate Courts) until he retired from the Singapore Legal Service in March of 2014. Upon retiring from the Singapore Legal Service, he returned to private practice. He is a Senior Consultant at RHT Law Asia. He is a Fellow of the Singapore Institute of Arbitrators and the Chartered Institute of Arbitrators. He also sits on various governmental committees including the Institutional Disciplinary Advisory Committee which advises the Commissioner of Prisons on punishment of prison inmates and the Military Court of Appeal. He is also a Vice President of the Singapore Academy of Law. In 2002, he was awarded the Public Service Medal by the President of the Republic of Singapore for his contributions to the Military Court of Appeal. Mr Dinesh Dhillon - President, Singapore Institute of Arbitrators; Partner, Allen & Gledhill LLP

Mr. Dinesh Dhillon practises international arbitration and litigation. He has acted as lead counsel in international arbitration for global multinational corporations in the telecommunications, airline, hotel, commodities, construction, manufacturing and projects industries. Apart from corporates, he has also represented sovereign states in international arbitration cases. He has represented clients in landmark cases before the Singapore courts relating to jurisdiction of arbitral tribunals, challenges to arbitration awards and attempts to resist enforcement of foreign arbitration awards. Dinesh has represented multinational companies in cases before the Singapore High Court and Court of Appeal relating to banking, corporate, employment, entertainment, insurance, property and shareholder disputes.

He has also acted for statutory boards in judicial review cases. Dinesh was called to the Singapore Bar in 1995. In 2004, he obtained the Graduate Certificate in International Arbitration from the National University of Singapore.
