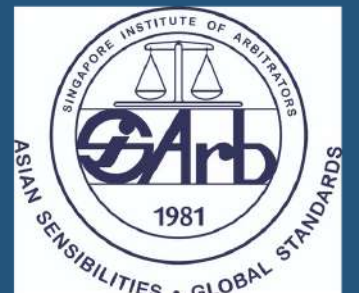

SARAH GRIMMER | TWENTY ESSEX

Sarah is a full-time Arbitrator Member at Twenty Essex. She has over 20 years of experience in international commercial, investment treaty, and public international law dispute resolution proceedings. She has been appointed as presiding arbitrator and co-arbitrator in international commercial disputes administered by the HKIAC, SIAC, and the ICC, and as presiding arbitrator in an investor-State treaty dispute administered by the PCA. From 2016 to 2022, Sarah served in the highly public role of Secretary-General of the HKIAC during which time it was ranked the third most preferred institution in the world. Prior to that, she spent a decade at the PCA where she administered inter-State, investor-State, and contractual disputes involving public entities. Sarah has also worked at the ICC International Court of Arbitration in Paris administering hundreds of commercial cases under the ICC Rules of Arbitration.
