

ELECTION STATEMENT



My name is Delphine Ho and I am running for the position of Council Member of the SI Arb Council 2022/2024. I have been a Fellow of SI Arb since 2020, and am currently a member of both the Education Committee and the Arbitration Bar Committee.

I strongly believe in the development and growth of arbitration expertise in Singapore and elsewhere. A key component of this is arbitration education: this includes not only introductory level courses to allow more people to gain an understanding of the peculiarities (and there are many!) of arbitration, but also courses designed to impart practical skills and tools to assist those interested in sitting as arbitrators. To this end, I have been teaching international arbitration at various levels for several years, including SI Arb's International Entry Course (IEC) and the Fellowship Assessment Course (FAC) programmes.

SI Arb's mission of education arbitration practitioners, promoting the use of arbitration and developing the arbitrator profession, therefore resonates with me. I hope to be able to further contribute to these aspects of SI Arb's mission, as well as to the arbitration community overall, as a Council Member.

My experience with arbitration has been varied: I have been arbitration counsel, a judicial officer, worked in an arbitral institution, and am now an independent arbitrator and mediator. This, I believe, has given me a unique perspective as to the needs of, and challenges faced by, the arbitration and ADR community. I believe that I can add positively to SI Arb's thought-leadership objectives, and actively participate in the development of new arbitration initiatives and processes. One of my areas of interest is the use of AI in arbitration decision-making, so as to reduce the overall costs of arbitration and increase access to justice for the individual layperson claimant. I think this is an area that needs to be explored to ensure that arbitration remains relevant and material in the overall ADR landscape.

I would be very honoured to serve as a Council Member if elected.

Candidacy to serve as a Council Member of the Singapore Institute of Arbitrators (SI Arb) from 2022-2024

Dear fellow SI Arb members:

With gratitude to my proposer and seconder, I wish to express my intent to run for election to be a Council Member of SI Arb for the term from 2022-2024. I set out below the reasons why I have decided to put my name forward for the election.

First, an introduction. I am a triple-qualified lawyer (New York, Singapore, and England & Wales), focusing my practice on both investment-treaty and commercial arbitration, as well as other cross-border disputes. After completing a general LL.B. in London and gaining work experience in Singapore, I specialised in international arbitration studies at Columbia Law School. Thereafter, I stayed on in New York to practice. The arrangement that I have with my firm allows me to be substantially involved in Singapore work.

To date, I have served both as a Committee Member of the Arbitration Bar Committee and as an Assistant Editor of the Singapore Arbitration Journal (SI Arb J). In these capacities, I have had the opportunity to represent the interests and concerns of members who practice as arbitration counsel, to assist with SI Arb's responses to consultations, to participate in its events, and to contribute to its publications. Additionally, I have published in a number of peer-reviewed international journals on various topics, including arbitration. I am up to date on practical and academic developments of relevance and interest to both the New York and the Singapore arbitration communities, and, as a diverse young practitioner in both jurisdictions, I am able to offer some unique perspectives on work internationalisation.

I stand for election with the goal of becoming even more deeply involved with the Institute's mission to meaningfully contribute towards educating, promoting, and developing the arbitration community, as a whole. Given the opportunity, I would like to work through SI Arb to promote more Singaporean representation, more Asian representation, and more female representation both locally and internationally, to raise awareness of what it means to be part of the Singaporean arbitration community. In particular, I hope to be able to share my experiences with younger practitioners who have an interest in arbitration, to continue to grow the SI Arb community in terms of thought leadership, representation, and a shared appreciation of both arbitration and other alternative dispute resolution processes.

Election Statement : Matthew Shaw

Dear Mr Goh

I wish to put myself forward for election to the Council of the Institute for the 2022-2024 period as kindly Proposed by Mr Tay and Seconded by Mr Pullen.

I have been a Member of the Institute for approximately 10 years during which time I previously served as a member of the Arbitration Bar Committee and the Scheme Arbitration Committee. Having now practiced arbitration in Singapore for almost 13 years, and intending to continue this for the rest of my career, I feel an responsibility and imperative now to contribute whatever I can to further the important work done by the Institute.

I was pleased take and pass the Fellowship Assessment Course (FAC) in 2020. The FAC has undergone a substantial revamp in recent years under Chor Leong's excellent leadership. It is now a very practical course with direct applicability and utility to the work of both experienced arbitrators and those sitting as an arbitrator in their very first cases. It is filled from start to finish with practical and useful guidance and instruction from the Course Director, Education Committee Members, the Teaching Faculty, and the Resource Panel.

Inspired by this, if elected to the Council I would like to make a meaningful contribution to further the education and accreditation functions of the Institute. Anecdotally, I understand that there is increasing demand for these functions from our constituency. The Institute should do what it can to meet this demand and make it a key area of focus over the next 2-year term.

Foreseeably this will require a substantial investment of time in creating high quality teaching materials with the approval of the Institute and a commitment in terms of teaching resources. It also would benefit from the contributions of those from diverse legal backgrounds and traditions to ensure that the courses we assemble speak to the cosmopolitan characteristics of our constituency and of arbitrations in Singapore.

If elected to the Council, would be delighted to have the opportunity to make a full contribution to these efforts by way of the preparation of teaching programs and materials and in terms of participating as course faculty on courses. I have some experience of teaching medium-to-large groups of mature adults due to my role on the University of Western Australia's international arbitration summer course, and from teaching on an LLM course in Jakarta.

The initial courses I have in mind might include teaching on the following subject matters: (1) Roles and Limitations of Tribunal Secretaries; (2) Procedural Techniques for Case Management in Complex Disputes; and (3) Practical Use of Time and Cost-Saving Measures. Other subject matters are of course available and it may be useful to establish an outline programme for these shortly after the re-formation of the Education Committee in the new term.

It would be an honour to be elected to the Council of the Institute to contribute everything that I can to the Institute's educational and accreditation work.
